DLA - claim it while you can!

What is DLA?

DLA means **disability living allowance** – a benefit for people who need help with mobility (getting around on foot), with personal care, or with preparing and cooking a main meal for one person. The amount of DLA depends on the type and amount of help that is needed. Weekly rates range from £21 to £134.40. **You have to be under age 65 when you claim.** DLA is not affected by earnings, other income or capital, and it can be kept while in paid work. It is also disregarded as income when assessing income related benefits such as housing benefit.

Claim before 10th June

DLA will be abolished for any new claims on or after 10/6/2013 (except for children under age 16) when a new benefit called Personal Independence Payment (PIP) replaces DLA for new claimants age 16 to 64. This means you have to claim before 10TH June or lose the chance to claim DLA altogether.

What happens after 10th June?

Until some time in 2015, anyone who gets an award of DLA that was claimed before 10/6/2013 will keep the award as long as they continue to meet the conditions of entitlement (or until the award runs out, if it has been awarded for a fixed period). Existing DLA awards may be assessed for transfer to the PIP scheme, but **this will not start happening before some time in 2015**, except where a change in relevant circumstances is reported. People already on DLA who have reached age 65 by 2015 will not be affected, and will be able to keep their DLA.
